

APACHE BOWHUNTERS CLUB RULES AND REGULATIONS

1) MEMBERSHIP:

- (A) The Executive Council will serve as an Orientation Committee to welcome new members into the club.
- (B) The Orientation Committee will see that each new member is given a packet containing information on Apache (Club rules, Constitution, etc.)
- (C) Membership to Apache will be accepted only by a member of the Orientation Committee.

2) MEETINGS:

- (A) Monthly club meetings will be held on the first Wednesday of the month at 6:30 P.M. starting in March of each year. During the Spring/Summer league, the meeting will be held immediately following shoot (approx: 8:00 P.M.) The September meeting will be held at the picnic, (date to be announced), no meeting will be held in October, December or January, the November meeting will be held at the last work party of the year (Sunday before Thanksgiving immediately following the work party., the February meeting will take place at the awards banquet (date to be announced).
- (B) The President will preside at all club meetings, in his or her absence the Vice President will preside. The Secretaries' minutes are to be read at each meeting, and the Treasurer will give a monthly report. The Bank statements are to be signed each month by the President, or a member of the Executive Council. The club is to be bonded.
- (C) Members wishing to speak at club meeting will be recognized and given two minutes to present their discussion. The President has the right to call for a vote in case of lengthy discussions.
- (D) The range and course will be closed during all meetings.

3) WORK PARTIES:

- (A) Club members are encouraged to attend all work parties.
- (B) Members with a non-working membership are excluded from having to attend work parties.
- (C) Members who have a working membership are required to attend at least two work parties per year to retain their membership in Apache. . If a member with a working membership fails to complete the minimum required work parties and wishes to renew their membership, they will be required to pay a \$100.00 penalty. If this is their first offense of failing to meet the required work parties they will still have the option of choosing a working or non-working membership after the penalty is paid. If this is their second offense of failing to meet the minimum work party requirements their only option will be to sign-up for a non-working membership after the penalty of \$100.00 has been paid. If this is not adhered to, membership will be denied for 3 years or until the penalty and membership fee for a working or non-working membership on the 1st offense and only a non-working membership on the 2nd offense has been paid in full.

3) **WORK PARTIES (Continued):**

- (D) Any member with a working membership who cannot attend the regularly scheduled work parties must contact the Vice President for work that can be done at alternative times to receive their work party credits.
- (E) Work parties will be under the direction of the Vice President.
- (F) The range and course will be closed during all work parties. This applies to both members with working and non-working memberships.

4) **GENERAL:**

- (A) The gate to the club grounds is to be kept locked at all times (except during work parties and shoots)
- (B) All vehicles are to be parked in designated areas; roads should not be blocked.
- (C) Adult members are responsible for the conduct and safety training of their children while using the club grounds. Any complaints will be directed to the parents.
- (D) A member may bring an adult guest to the range twice, after this they will be expected to join if they wish to continue to use the grounds. Out of town guests are exempt from this rule when accompanied by a member.
- (E) Invited youths may shoot the range if accompanied by an adult club member.
- (F) No hunting or running of dogs will be permitted on the grounds.
- (G) No firearms are to be fired on club grounds. Crossbows will be allowed at club events following the approval of safety rules governing their usage.
- (H) Broadheads are to be shot in designated areas only.
- (I) All pets must be kept on a leash at all times while on the grounds; owners must clean up after their pets.
- (J) Trash containers are on the grounds for your convenience, please use them.
- (K) Alcoholic beverages are not permitted on the range or course.
- (L) Anyone caught intentionally destroying club property, will be brought before the Executive Council for possible prosecution and/or suspension from further club use. Full restitution will be sought for damages.
